### ORDER:

The Hon'ble Chief Minister of Tamil Nadu has made the following announcement under Rule-110 on 07.05.2022:-

"ஆட்சிக்கு வந்த பிறகு எடுக்கப்பட்ட ஒரு புள்ளி விவரத்தில் கிடைத்த தகவல் மிக மிக மனவேதனையைத் தருவதாக இருக்கிறது. தமிழ்நாட்டில் உள்ள 6 வயதுக்கு உட்பட்ட குழந்தைகளைப் பரிசோதித்ததில் அவர்களில் பெரும்பாலானவர்கள் ஊட்டச்சத்துக் குறைபாடு உள்ளவர்களாக இருந்தார்கள். வயதுக்கேற்ற எடையும் இல்லை. வயதுக்கேற்ற உயரமும் இல்லை. மிக, மிக மெலிந்து இருக்கின்றார்கள். உடலில் உறுதி இல்லாவிட்டால் அவர்களது எதிர்காலம் என்பது கேள்விக்குறியாக ஆகிவிடும் என்பதை உணர்ந்து இதற்கென தனியாக ஒரு திட்டத்தைத் தீட்ட நான் ஆலோசனை கூறினேன்.

6 வயதுக்கு உட்பட்ட குழந்தைகளை நலமுடன் வளர்த்தெடுக்கும் நோக்கத்துடன் இத்திட்டம் தொடங்கப்பட்டுள்ளது. பரந்துபட்ட அளவில் குழந்தைகளுக்கு மருத்துவப் பரிசோதனைகள் செய்ய இருக்கிறோம். மருத்துவ உதவி தேவைப்படும் குழந்தைகளுக்கு மருத்துவ உதவியும், ஊட்டச்சத்து தேவைப்படும் குழந்தைகளுக்கு சிறப்பு ஊட்டச்சத்து திட்டம் ஒன்றும் ஏற்படுத்த அரசு முடிவெடுத்துள்ளது."

2. In the letter second read above, the Director cum Mission Director, Integrated Child Development Services has stated that the RBSK team have screened in all districts for one month covering around 10 lakhs malnourished children and found that 1,11,216 children are severely malnourished and 3,07,036 children are moderately malnourished in the age group of 6 months to 6 years and 11,917 children are severely malnourished and 16,415 children are moderately malnourished in the age group of 0 to 6 months. Further she has also stated that 40,249 Nutri Kits at the rate of 2 Nos. of Nutri Kits to the mothers of 11,917 severely malnourished children and one Nutri Kit to the mothers of 16,415 moderately malnourished children in the age group of 0 to 6 months may be supplied by the Health and Family Welfare Department from their funds through Tamil Nadu Medical Services Corporation Limited.

3. The Director cum Mission Director, Integrated Child Development Services has requested to sanction a total sum of Rs.35.26 crore at the rate of Rs.18.68 crore towards procurement and supply 62.28 lakh sachets (Rs.30/- per kit) of RUTF (Ready to Use Therapeutic Food) to 1,11,216 severely malnourished children in the age group of 6 months to 6 years for 8 weeks through Tamil Nadu Medical Services Corporation Limited and Rs.16.58 crore towards procurement and supply of 1381.66 metric tons of Re-formulated Sathu Maavu Biscuits for 3,07,036 Moderately Malnourished children in the age group of 6 months to 6 years for 3 months (i.e. 90 days) from the Weaning Food Manufacturing Women Industrial Cooperative Societies under ICDS.

4. After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, the Government issue following orders:-

- i. The Director cum Mission Director, Integrated Child Development Services is permitted to procure and supply 62.28 lakh sachets of RUTF (Ready to Use Therapeutic Food) (Rs.30/- per sachet) as 'One Time Intervention' to 1,11,216 Severely Malnourished Children (one sachet per child per day) in the age group of 6 months to 6 years for 8 weeks (i.e. 56 days) under Integrated Child Development Services through Tamil Nadu Medical Services Corporation Limited as per the specification as detailed in the Annexure to this order.
- ii. Sanction is accorded for a sum of Rs.18,68,00,000/- (Rupees eighteen crore and sixty eight lakh only) towards procurement and supply of 62.28 lakh sachets (approx. Rs.30/- per kit) of RUTF (Ready to Use Therapeutic Food) to 1,11,216 Severely Malnourished Children in the age group of 6 months to 6 years for 8 weeks (i.e. 56 days).

5. The expenditure sanctioned in para-4(ii) above shall be debited under the following heads of account:-

"2236 Nutrition - 02 - Distribution of Nutritious food and beverages 101 Special Nutrition Programmes - State's Expenditure JN-Tamil Nadu Integrated Child Development Services Scheme Phase-III - 367 Feeding/Dietary charges - 09 others.  
(IFHRMS DPC 2236 02 101 JN 36709)".

6. The expenditure sanctioned in para 4(ii) above shall constitute an item of "New Service" and the approval of the legislature will be obtained in due course. Pending



approval of the Legislature, the expenditure may initially be met by drawl of an advance from the Contingency Fund. The Director cum Mission Director, Integrated Child Development Services is directed to apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-1) Department. The Director cum Mission Director, Integrated Child Development Services is also directed to send necessary draft explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2022-2023 to Government in Finance (BG-I/SW) Department at the appropriate time without fail.

7. This order issues with the concurrence of Finance Department vide its U.O.No.44960/Fin(SW)/2022, dated 30.09.2022 with Additional Sanction Ledger No.1386 (One thousand three hundred and eighty six) (IFHRMS ASL No.2022091386).

## ANNEXURE

### Product Description

RUTF is a smooth, homogeneous, thick paste containing ground peanuts, sugar, oil, milk powder and vitamin and mineral premix. It is squeeze out of sachet and given to the infant or child 92 gms in a sachet.

### Nutritional composition per 100g of RUTF paste

1. Moisture content: 2.5% maximum
2. Water activity : 0.6 maximum
3. Energy : 2176-2301kJ 520-550 kcal
4. Proteins\*: 10-12% total energy 12.8-16.2% by weight
5. Lipids: 45-60% total energy 25.8-36.3% by weight
6. n – 6 fatty acids : 3-10% total energy
7. n – 3 fatty acids: 0.3 -2.5% total energy
8. Trans- fatty acids : <3% total fat
9. Fibre : <5%
10. Free Sugar <20% of total energy

At least half of the protein contained in RUTF paste comes from milk /diary products.

### Minerals per 100g of RUTF paste

1. Sodium : 290 mg maximum
2. Potassium : 1100-1400 mg
3. Calcium : 300 – 600 mg
4. Phosphorous\* : 300 – 600 mg
5. Magnesium : 80 – 140 mg
6. Iron : 10 – 14 mg
7. Zinc : 11 – 14 mg
8. Copper : 1.4 -1.8 mg
9. Selenium : 20 – 40 micrograms (ug)
10. Iodine : 70 – 140 micrograms (ug)

Expressed in terms of non – phytate Phosphorous.

### Vitamins per 100g RUTF paste

1. Vitamin A (Retinol Equivalent) 0.8 – 1.1 mg
2. Vitamin B1 (Thiamine) 0.5 mg minimum
3. Vitamin B2 (Riboflavin) 1.6 mg minimum
4. Vitamin B3 (Niacin) 5 mg minimum

5. Vitamin B5 (Pantothenic acid): 3 mg minimum
6. Vitamin B6 (Pyridoxine): 0.6 mg minimum
7. Vitamin B7 (Biotin): 60 ug minimum
8. Vitamin B9 (Folic acid): 200 ug minimum
9. Vitamin B12 (Cyanocobalamin): 1.6 ug minimum
10. Vitamin C (Ascorbic acid): 50 mg minimum
11. Vitamin D (Cholecalciferol): 15-20 microgrammes (ug)
12. Vitamin E (Tocopherol): 20 mg minimum
13. Vitamin K (Phytonadione): 15 – 30 microgrammes (ug)
