ORDER:-

In the Government Order first read above, orders were issued among others, introducing State Level Regional Tender System and the Director cum Mission Director, Integrated Child Development Services was permitted to float State Level Regional Tender for procurement of AGMARK quality eggs (hen) under Puratchi Thalaivar M.G.R. Nutritious Meal Programme and Integrated Child Development Services for a period of one year by following the provisions contained in Tamil Nadu Transparency in Tenders Act, 1998 and Rules, 2000.

2. In the Government Order second read above, orders were issued permitting the Director cum Mission Director, Integrated Child Development Services to float State level Regional Tender and to finalize the tender for procurement and supply of AGMARK quality eggs (hen) for children beneficiaries under Puratchi Thalaivar MGR Nutritious Meal Programme and Integrated Child Development Services for a period of one year from 01.11.2022 to 31.10.2023 by following the

terms and conditions laid down in G.O.(Ms) No.45, Social Welfare and Women Empowerment (SW4-3) Department, dated 05-08-2021 as well as the provisions contained in Tamil Nadu Transparency in Tenders Act 1998 and Rules 2000.

3. The Director cum Mission Director, Integrated Child Development Services in the letter third read above has stated that based on the Government Orders, State Level Regional Tender for the procurement of eggs was floated and finalized on 20.10.2022 and the selected contractors have been supplying eggs to Nutritious Meal Programme and Integrated Child Development Services centres from 01.11.2022.

4. The Director cum Mission Director, Integrated Child Development Services has also stated that the contract period for supply of eggs is up to 31.10.2023. Hence a fresh State Level Regional tender for procurement and supply of eggs for children beneficiaries under Nutritious Meal Programme and Integrated Child development Services Scheme has to be floated at the earliest i.e during August 2023.

5. The Director cum Mission Director, Integrated Child Development Services has therefore requested the Government to issue necessary orders permitting the Director cum Mission Director, Integrated Child Development Services for floating State Level Regional Tender and finalizing the tender for procurement of eggs for children beneficiaries under Nutritious Meal Programme and Integrated Child Development Services Scheme for a period of one year from 01.11.2023 to 31.10.2024.

6. The Government have examined the proposal of the Director cum Mission Director, Department of Integrated Child Development Services carefully and permit the Director cum Mission Director, Department of Integrated Child Development Services to float State level Regional Tender and to finalize the tender for procurement and supply of AGMARK quality eggs (hen) for children beneficiaries under PTMGR Nutritious Meal Programme and Integrated Child Development Services for a period of one year from 01.11.2023 to 31.10.2024 by following the terms and conditions laid down in G.O.(MS).No.45, Social Welfare and Women Empowerment (SW4-3) Department, dated 05.08.2021 as well as the provisions contained in Tamil Nadu Transparency in Tenders Act, 1998 and Rules 2000.

7. This order issues with the concurrence of Finance Department vide its U.O.No.27180/Fin(SW)/2023, dated. 01.08.2023.
