ORDER:-

In the letter first read above, the Government of India has issued the Operational guidelines for implementation of Saksham Anganwadi and POSHAN 2.0 during the 15th Finance Commission period 2021-2022 to 2025-2026, wherein the Government of India has approved a sum of Rs.1.00 lakh per Government owned Anganwadi Centres as a new initiative for upgradation of Anganwadi centres as “Saksham Anganwadi”.

2. In the letter second read above, the Government of India have approved and released a sum of Rs.2,90,76,000/- towards its 60% share for upgradation of Anganwadi centres in two aspirational districts for the year 2022-2023 and the same has been credited into the State consolidated fund on 03.01.2023.

3. In the letter third read above, the Director cum Mission Director, Integrated Child Development Services has stated that since any release made by the Government of India under the Centrally Sponsored Scheme to State has to be credited into the respective Single Nodal Agency account of the scheme within 21

days from the date of receipt of the money into the consolidated fund as per the revised financial procedures of Government of India, a sum of Rs.2,90,76,000/- released by Government of India has been parked into the Single Nodal Agency account of Upgradation and construction of Anganwadi Centres.

4. The Director cum Mission Director, Integrated Child Development Services has requested permission to park a sum of Rs.1,93,84,000/- towards matching 40% share of State Government into the above Single Nodal Agency account of Upgradation and construction of Anganwadi Centres within 40 days from the date of receipt of the release from Government of India against the 60% of Government of India share of Rs.2,90,76,000/- towards upgradation of Anganwadi centres for the year 2022-2023.

5. After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, the Government accord permission to the Director cum Mission Director, Integrated Child Development Services to park a sum of Rs.1,93,84,000/- (Rupees One crore ninety three lakh and eighty four thousand only) towards matching 40% share of State Government into the Single Nodal Agency Account of Upgradation and construction of Anganwadi Centres for the year 2022-2023 against the 60% of Government of India share of Rs.2,90,76,000/- for upgradation of Anganwadi centres as detailed below:-

"4236-Capital Outlay on Nutrition - 80 - General 800 - Other Expenditure – Schemes Shared between State and Centre - UG - Construction of Anganwadi Centres under restructured pattern of Integrated Child Development Services Scheme – State Share - 416 - Major Works -01. 7. Necessary funds for the expenditure sanctioned in paragraph-5 above has been provided in RE 2022-2023.

8. The Guidelines of Government of India shall be strictly followed. Social Audit shall also be ensured as per the Guidelines and Utilisation Certificate shall be

sent to Government of India at appropriate times as per the norms with a copy marked to Government.

9. This order issues with the concurrence of Finance Department vide its U.O. No.5955/Fin(SW)/2023, dated 13.02.2023.
