Social Welfare and Women Empowerment Department – Anganwadi Services – Sanction of expenditure towards procurement and supply of two sets of unisex readymade colour uniforms in banian cloth to pre-school education Anganwadi children in 30 Districts for the year 2022-2023– Orders – Issued.

ORDER:-

In the Government order first read above, orders have been issued among other things, sanctioning a sum of Rs.4,14,92,000/- towards procurement and supply of two sets of readymade colour uniforms at the rate of Rs.262.50 per child (Rs.131.25 per set) including transport charges and Goods and Service Tax to 1,58,063 pre-school children in the age group 2-6 years in 9,205 Anganwadi centres in seven districts namely, Coimbatore, Kanyakumari, Karur, The Nilgiris, Sivagangai, Thoothukudi and Tiruppur for the year 2022-2023 by following the centralized tender procedures in accordance with the Tamil Nadu Transparency in Tenders Act, 1998 and Rules, 2000.

2. In the Government order second read above, orders have been issued among other things, sanctioning a sum of Rs.24,80,00,000/- towards procurement and supply of two sets of readymade colour uniform at the rate of 262.50 per child (Rs.131.25 per set) including transport and Goods and Service Tax to preschool Anganwadi children (other than LKG/ UKG beneficiaries) in the age group of 2 to 5+ years attending Anganwadi centres in twenty five districts for the year 2021-2022 by following centralized tender procedures in accordance with the Tamil Nadu Transparency in Tenders Act, 1998 and Rules, 2000.

3. In the Government order third read above, orders have been issued, among others things, sanctioning a sum of Rs.6.00 lakh to conduct evaluation study

on provision of readymade colour uniforms to pre-school children in the age group of 2 to 6 years attending Anganwadi centres in order to know whether the objective of the scheme is achieved.

4. In the letter fourth read above, the Director cum Mission Director, Integrated Child Development Services has sent proposal stating that the readymade colour uniforms need not to be provided to seven districts viz., Coimbatore, Kanyakumari, Karur, The Nilgiris, Sivagangai, Thoothukudi and Thiruppur since readymade colour uniforms were provided during the year 2022-2023. Based on the study report submitted by M/s.M.S.Swaminathan Research Foundation, Chennai on provision of uniforms to preschool Anganwadi children as per the Government order third read above, now it is proposed to procure and supply unisex readymade colour uniforms made out of banian cloth for the year 2022-2023 and due to escalation of cost, the cost of uniforms may fixed at Rs.150/- per set (Rs.300/- per child) including transportation, Goods and Service Tax and other taxes.

5. The Director cum Mission Director, Integrated Child Development Services has sent proposal to sanction a sum of Rs.25,22,61,600/- towards supply of two sets of unisex readymade colour uniform in banian cloth at the rate of Rs.300/- per child (Rs.150/- per set) including transportation, Goods and Service Tax and other taxes to 8,40,872 preschool children in the age group of 2 to 5+ years attending in Anganwadi centres in 30 districts for the year 2022-2023 by following Centralised Tender procedures as per Tamil Nadu Transparency in Tenders Act 1998, Rules 2000.

6. After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, the Government issue the following orders:-

- i. The cost of unisex readymade colour uniforms in banian cloth is fixed at Rs.150/- per set i.e.Rs.300/- per child for two sets including transportation, Goods and Service Tax and other taxes.
- ii. Sanction is accorded for a sum of Rs.25,22,61,600/- (Rupees Twenty five crore twenty two lakh sixty one thousand and six hundred only) towards supply of two sets of unisex readymade colour uniforms in banian cloth at the rate of Rs.300/- per child (Rs.150/- per set) including transportation, Goods and Service Tax and other taxes to 8,40,872 preschool children in the age group of 2 to 5+ years attending Anganwadi centres in 30 districts viz., Ariyalur, Chennai, Dharmapuri, Dindigul, Nagapattinam, Namakkal, Perambalur, Ramanathapuram, Salem, Thiruvannamalai, Theni, Thiruvavarur, Thirunelveli, Tenkasi, Thiruchirappalli, Vellore, Ranipet, Thirupattur, Villupuram, Kallakurichi, Virudhunagar, Cuddalore, Erode, Kancheepuram, Chengalpet, Krishnagiri, Madurai, Pudukottai, Thanjavur and Thiruvallur Districts as detailed in the annexure to this order for the year 2022-2023.
- iii. The Director cum Mission Director, Integrated Child Development Services is permitted to procure and supply the unisex readymade colour uniforms in banian cloth by following Centralised Tender procedures as per Tamil Nadu Transparency in Tenders Act 1998, Rules 2000.
- iv. The Director cum Mission Director, Integrated Child Development Services is permitted to make inter-district transfer of readymade colour uniforms / funds based on the actual requirement (No. of beneficiaries), if required, as the beneficiaries may vary, within overall financial allocation.

- v. As 2022-2023 comes to end shortly, the Director cum Mission Director, Integrated Child Development Services is directed to distribute the readymade colour uniforms from next academic year 2023-2024.

7. The expenditure sanctioned at paragraph-6(ii) above shall be debited under the following head of account:-

2236 Nutrition – 02 Distribution of Nutritious food and Beverages – 101 Special Nutrition programmes – State's Expenditure – JN Tamil Nadu Integrated Child Development Services Scheme - Phase III – 346 Clothing, Tentage and Stores – 01 Clothing, Tentage and Stores".

8. The expenditure sanctioned in paragraph-6(ii) above shall be met from the funds available in RE 2022-2023 under the relevant head of account.
