#### ORDER:-

In the Government Order first read above, orders were issued among others, introducing State Level Regional Tender System and the Director cum Mission Director, Integrated Child Development Services has been permitted to float State Level Regional Tender for procurement of AGMARK quality eggs (hen) under Puratchi Thalaivar M.G.R. Nutritious Meal Programme and Integrated Child Development Services for a period of one year by following the provisions contained in Tamil Nadu Transparency in Tenders Act, 1998 and Rules, 2000.

2. The Director cum Mission Director, Integrated Child Development Services in the letter second read above has stated that based on the above Government Order State Level Regional Tender for the procurement of eggs was floated and finalized based on region wise egg rates on 08.10.2021 and the selected contractors have been supplying eggs to Nutritious Meal Programme and Integrated Child Development Services centres from 01.11.2021 onwards.

The Director cum Mission Director, Integrated Child Development Services has also stated that contract period for supply of eggs is only upto 31.10.2022 and a fresh State Level Regional Tender for procurement and supply of eggs for children beneficiaries under Nutritious Meal Programme and Integrated Child Development Services has to be floated at the earliest (i.e.) during August 2022.

4. The Director cum Mission Director, Integrated Child Development Services has therefore requested the Government to issue necessary orders permitting the Director cum Mission Director, Integrated Child Development Services for floating

State Level Regional Tender and finalizing the tender for procurement of eggs for children beneficiaries under Nutritious Meal Programme and Integrated Child Development Services for a period of one year from 01.11.2022 to 31.10.2023.
